Dear Participant,

The counseling network *Alle an Bord! – Perspektive Arbeitsmarkt für Geflüchtete* helps refugees to integrate into work, training, school and study. We need to document your personal data, for example your name, place of residence, age, gender, residence status and duration of project participation and the results of our work. This means that we write down the data and store it in the computer in a DSGVO (Data Protection Regulation) compliant database (IBB – database for participants). In our software IBB we write down the data in categories: master data, administrative data, educational and professional data, activities and counselling sessions. In case of an inspection, representatives of the Ministry of Economy, Labor, Transport, Technology and Tourism or the Investitionsbank Schleswig-Holstein can look at this information. They check whether we really have participants, because only then the counselling network *Alle an Bord! - Perspektive Arbeitsmarkt für Geflüchtete* receives funding, so that the counselling is free of charge for you. The information of all project participants is pseudonymized for an evaluation. This means that your name will no longer appear there. We need the information for the evaluation of the project results, for example, to see how many women and men participated, how old the participants were or other things. We are obliged to prove to the state of Schleswig-Holstein and the ESF PLUS (European Social Fund) how the funding (tax money) was used.

We also store the information we receive from employers, counselling centers, authorities, courts, attorneys, job centers, etc.

In order for us to process your data, we need your consent. Without this consent, participation in the counselling network *Alle an Bord! – Perspektive Arbeitsmarkt für Geflüchtete* is not possible.

Articles 15-20 of the GDPR govern your rights. You have the right to information about the personal data concerning you.
